2022 FLORIDA LEGISLATIVE SPECIAL **SESSION C UPDATE**

Just prior to the start of the Florida Legislative Special Session C (what was scheduled to be a special session specifically dealing with congressional redistricting maps), the Governor, Speaker, and Senate President announced the addition of two issues on the special session call. The first was to address the future of special act-created special districts (specifically any that were formed prior to the 1968 State Constitution and not reconstituted since); and the second to eliminate the exception for companies that own theme parks from the 2021 Social Media transparency and de-platforming legislation.

The special district legislation, after being passed and signed into law, officially sunsets six special districts on June 1, 2023. Among the six that could be eliminated is the Reedy Creek Improvement District. Over the next several months, the Walt Disney Company, the Reedy Creek Improvement District, and the Florida legislature will be exploring a path forward and it will be critical that our Central Florida region, along with CFHLA and our industry partners, stays engaged in those conversations.

Additionally, on Tuesday, April 26th, the Governor issued a proclamation calling for a second Special Session D to consider legislation related to property insurance, reinsurance, changes to the Florida Building Code to improve the affordability of property insurance, the Office of Insurance Regulation, civil remedies, and appropriations.

This next special session will begin on Monday, May 23rd at 12:00pm and will extend no later than 11:59 p.m. on Friday, May 27th.

ORANGE COUNTY'S PROPOSED TRANSPORTATION INITIATIVE

On Tuesday, April 26th, the Board of Orange County Commissioners **agreed to advance the proposed Transportation Sales Tax initiative and place it on the November 2022 general election ballot**. CFHLA spoke in favor of this motion and it was approved by a vote of 4-3.

On behalf of the CFHLA Board of Directors, we are thankful to Mayor Demings and Commissioners Moore, Uribe and Gomez Cordero for advancing the proposed one-penny Transportation Sales Tax initiative forward and placing it onto the November 2022 general election ballot.

CFHLA believes that now is the time to have a discussion surrounding our long-term transportation needs as a region. Our hospitality and tourism partners have long sought a more reliable and consistent transportation system, that helps service the hundreds of thousands of employees within our industry, as well as our future guests to Central Florida. By allowing the voters of Orange County to consider establishing a new revenue source, that is **separate from the Tourism Development Tax and funded by at least 51% from out-of-town guests**, is a huge step forward in developing a dedicated source of funding for our current and long-term public transportation initiatives and infrastructure needs within our community.



REGIONAL TOURIST DEVELOPMENT TAX UPDATE

Orange County

Orange County announced that the February Tourist Development Tax collection was at \$28,362,00. That is a 173.9% increase over February 2021. Additionally, month-over-month, February's collections were higher than January's by \$5.9 million and higher than February 2020 collections by \$255,800. These were the highest February collections ever and the third highest monthly collections ever for Orange County!




Osceola County

Osceola County announced that the February Tourist Development Tax collection was at \$6,200,000. This is the 5th highest monthly collections ever for Osceola County (16% higher than March 2019) and a 127% increase over January 2021. Additionally, month-over-month, February's collections were nearly a 23% increase from January 2022 and a 16% increase from January 2019.



Seminole County

Seminole County announced that the February Tourist Development Tax collection was at **\$583,915**. That is roughly an **9% increase** from January 2022! This is Fantastic News!
